How to register:

Complete and submit a FL Voter Registration Application Form by mail or in person to:

- ◆ Supervisor of Elections' office—5200 College Rd, Key West, FL 33040
- ◆ Any office that issues driver licenses,
- ◆ Any voter registration agency (public assistance office, center for independent living, office serving persons with disabilities, public library, or armed forces recruitment office), or
- ◆ The Division of Elections

Register online: RegistertoVoteFlorida.gov

Voter Registration Requirements

- U.S. citizen and resident of Florida and county
- At least 18 years old (or 16 for pre-registration)
- Not adjudicated mentally incapacitated, or if so, voting rights restored.

Deadline to Register for the Primary Election is **July 22nd**
Deadline to Register for the General Election is **Oct. 2nd**



HISTORICAL REMEMBRANCE

Fair Housing Act



In 1968, Title VIII of the Civil Rights Act was passed. It prohibits housing discrimination, including refusal to rent or sell a home to any person based on their color, race, national origin, or religion. In 1974, a prohibition of discrimination on the basis of one's gender was added, and in 1988, families with children and people with disabilities were added to the list of protected classes. In February, 2021, HUD implemented a prohibition of LGBT discrimination in federally assisted housing programs.

A MESSAGE FROM THE EXECUTIVE DIRECTOR

As the Executive Director of Key West Housing Authority, I want to take this opportunity to remind you that the upcoming hurricane season is expected to be particularly active. Your safety is our utmost priority, and we are committed to ensuring that everyone is well-prepared for any potential storms. Here are some important steps you can take to protect yourselves and your families:

Stay Informed: Keep up to date with weather forecasts and advisories from local authorities and trusted news sources. Sign up for emergency alerts if you haven't already.

Prepare an Emergency Kit: Ensure you have essential supplies such as non-perishable food, water, medications, flashlights, batteries, and a first aid kit. Don't forget necessary items for pets and any specific needs of your family members.

Know Your Evacuation Routes: Familiarize yourself with the local evacuation routes and the locations of nearby shelters.

Make a family emergency plan that includes meeting places and contacts.

Secure Your Home: Take steps to safeguard your home, such as securing outdoor furniture, ensuring windows are protected, and checking that your emergency exits are clear.

Follow Official Guidance: If an evacuation order is issued, please follow it promptly. Your cooperation is essential for your safety and that of your neighbors.

Back to School 2024 Sales Tax Holiday

ITEMS EXEMPT FROM SALES TAX:

- Learning aids and jigsaw puzzles selling for \$30 or less
- Most school supplies selling for \$50 or less
- Clothing, footwear and accessories selling for \$100 or less
- Computers and related accessories selling for \$1,500 or less (when purchased for non-commercial and personal use)

Disaster Preparedness Sales Tax Holiday

\$10 or less

- Wet dog or cat food if sold individually or the equivalent if sold in a box or case

\$15 or less

- Manual can openers
- Collapsible or travel-sized food or water bowls for pets
- Cat litter pans
- Pet waste disposal bags
- Hamster or rabbit substrate

\$20 or less

- Reusable ice
- Leashes, collars, and muzzles for pets
- Pet pads

\$25 or less

- Cat litter weighing 25 or fewer pounds

Maximizing Savings:

How to Take Advantage of Sales Tax Holidays

Sales tax holidays offer an opportunity for savvy shoppers to save money by timing their purchases to coincide with designated periods where specific items are exempt from sales tax. These holidays are set by the state, providing a financial break on essential items like clothing, footwear, school supplies, tools, and disaster preparedness items. By strategically planning your shopping, you can keep more money in your pocket!

Sales tax holidays are short-term periods, usually lasting 1 to 4 weeks, during which sales tax is waived on certain categories of goods. The amount you save during a sales tax holiday depends on your location and the items you purchase. For instance, let's consider Monroe County with a sales tax rate of 7.5%. Here's how much you can save on clothing and footwear during a tax-free period:

- Clothing: If you purchase \$200 worth of clothing, you save \$15 in sales tax.
- Footwear: Buying \$150 worth of shoes saves you \$11.25 in sales tax.

Here's a table to illustrate the savings for different purchase amounts:

Purchase Amount	Tax Savings at 7.5%
\$50	\$3.75
\$100	\$7.5
\$150	\$11.25
\$200	\$15.00



Tips for Maximizing Savings

1. Plan Ahead: Mark the sales tax holiday dates on your calendar and make a list of items you need to purchase. This will help you stay focused and avoid impulse buys.
2. Know the Rules: Check the specific rules for each holiday, like limits on the cost per item that qualifies for the exemption. For example, an item of clothing during the Back to School tax holiday needs to be \$100 or less to be tax-exempt.
3. Combine with Other Discounts: Sales tax holidays often coincide with other sales or seasonal discounts. Combining these promotions can lead to substantial savings.
4. Stock Up on Essentials: Use this time to buy necessities that you will need throughout the year, such as school supplies, basic clothing, cat & dog food, and batteries. This way, you save on taxes and also reduce future shopping trips!



Sales tax holidays are a valuable opportunity for consumers to save money on essential items. By planning purchases around these tax-free periods, understanding the rules, and combining the savings with other discounts, shoppers can significantly reduce their expenses. Whether you're buying school supplies for the kids or updating your wardrobe, timing your purchases to align with sales tax holidays can make a big difference in your budget. Happy shopping!
