On Friday, September 2nd, the Housing Authority hosted a sign unveiling ceremony under the covered pavilion at the Lang B. Milian Apartments. The apartment complex was renamed after Resident Commissioner Annette Milian Mobley's father Lang Milian, who served on the KWHA board in the 1970s, and was also a City of Key West Commissioner. The gathering was attended by Lang Milian's immediate and extended family, current housing authority board members, housing authority staff, and distinguished members of the community, who all came to honor former Commissioner Lang Milian.

Randy Sterling, executive director of the housing authority, stated, "The new name of this housing complex honors a man who served this community with honor and integrity and stood for people across the entire island, including working families that live here on this property. It is so fitting that his name now graces the fence that protects this property."

Housing Authority Board Chairman Johnny Parks, Jr. said, "Our vision is to take this property, which has served our community's affordable housing needs for decades, and provide newer, safer, eco-conscious housing. Today, we honor Lang Milian with the new sign with his name, and tomorrow, we honor him by building a new complex to house more residents in a better way."

Resident Commissioner Annette Milian Mobley, daughter of Lang Milian, currently serves on the KWHA Board of Commissioners as the Resident Commissioner, continuing her father's legacy of service.

HISTORICAL REMEMBERANCE In October of 1947, George Mills White,



the executive secretary of the KWHA, traveled to Miami and reported to a congressional subcommittee that there was a severe housing shortage in Key West. He was joined by (pictured from left to right) City Commissioner Albert B. Cooper, City Commissioner Ralph Betancourt, both members of the Key West Housing Authority; the Rev. Motor Fuel Tax Relief

October 1st—31st, 2022

The Florida Motor Fuel Tax Relief Act of 2022 reduces the tax rate on motor fuel by 25.3 cents per gallon. Passed by the Florida Legislature and signed into law by Governor Ron DeSantis, the tax rate reduction begins Saturday, October 1, and extends through Monday, October 31. The tax rate reduction applies to all gasoline products, any product blended with gasoline and any fuel placed in the storage supply tank of a gasoline-powered motor vehicle.



GARDEN VIEW APARTMENTS UPDATE

5220 College Road, North Stock Island

The Garden View Apartments is a 2.6-acre property comprised of three (3) structures with a total of one hundred and three (103) 1-bedroom/1-bathroom units. Six (6) of the units will be fully compliant with the American with Disabilities Act. Eleven (11) of the units will be rented to extremely low-income households (at or below 25% AMI) and the other ninety-two (92) units will be rented to low-income households (at or below 80% AMI). Due to the size of the units, households will be restricted to no more than 3 people.

The property will include covered storage areas for bikes and scooters, offstreet parking for automobiles, and easy direct access to the North Line bus, the South Line bus, and the Lower Keys Shuttle.

Construction of the property is well over 60% complete. The KWHA expects to be able to start welcoming new residents as early as Spring 2023. Prior to that, the KWHA will open a site-specific waiting list, using a completely online application intake process which will be available at www.cityofkeywest.housingmanager.com. The open application period will be detailed in notices published by the KWHA. The notices will be advertised in the Key West Citizen, in all housing authority rental offices in Key West, and at www.kwha.org.

LOOKING BACK

Summer was a busy season for the Housing Authority! Below are just a few of the highlights:

- ♦ A KHWA contractor installed new playground equipment and shade sails at both the Lang Milian Apartments and Robert Gabriel Site C.
- ♦ Work began to install 4-foot white picket fencing around the entire perimeter of Robert Gabriel Site A.
- ◆ Staff created a Tenant Selection Plan for the Garden View Apartments.
- ♦ The KWHA and the SPCA hosted a "Wellness Clinic" inside the Senior Citizen Plaza Auditorium, offering heavily discounted vaccine packages for cats and dogs as well as low cost flea prevention and microchips. The next "Wellness Clinic" will be held on Friday, September 23rd, in the Community Center at the Roosevelt C. Sands, Jr. Affordable Housing Complex located at 105 Truman Avenue. All residents and their fur babies are encouraged to take advantage of all the clinic has to offer!
- ♦ Major concrete spalling concrete repair is nearly complete on a section of the building at the Senior Citizen Plaza.
- ◆ Staff implemented a new updated Administrative Plan for the HCV (Section 8) program.
- ♦ The KWHA hired an arborist contractor to provide on-going major tree trimming.
- ♦ Staff secured a preliminary approval for rezoning of the Lang Milian Apartments property at 301 White St. to allow for future redevelopment.
- ♦ New signage was hung at both the George Allen Apartments and the Lang Milian Apartments.

Commissioner Roosevelt C. Sands, Jr.- 52 Years of Service

On Tuesday, September 13th, 2022, the Key West Housing Authority (KWHA) Board of Commissioners, and its staff, recognized Mr. Roosevelt C. Sands Jr. for his 52 years of service to the KWHA Board.

Commissioner Sands was originally appointed to the board on September 14th, 1970, by Mayor Delio Cobo. He was then reappointed twelve times by Mayors Tom Sawyer, Charles "Sonny" McCoy, Tony Tarracino, Dennis Wardlow, Jimmy Weekly, Morgan McPherson, and Craig Cates.

Executive Director Randy Sterling, during an expression of gratitude toward Commissioner Sands, shared some of the Commissioner's many

accomplishments, which include the development of the Senior Citizens Plaza and Roosevelt Gardens Apartments, the redevelopment of the Jack T. Murray Senior Citizen Complex, the redevelopment of his namesake property the Roosevelt C. Sands, Jr. Affordable Housing Complex, and the acquisition of Poinciana Plaza, the acquisition of the Washington Street Apartments, and most recently the development of Poinciana Gardens Senior Living Complex and the current development of Garden View Apartments.

Board Chairman Johnny Parks, Jr. said, "I remember when I was a teenager, and you were my boss, and we would remove window units from homes and replace or repair them. You would always take the heavy end of the unit. Then as an adult I saw you still always offer to take the heavy end, Commissioner. It has been an honor to serve with you on this Board." The other members of the Board shared their sincerest sentiments of gratitude for Commissioner Sands' wisdom, knowledge, guidance, and the most powerful and heartfelt invocations ever witnessed.

The board position is 100% volunteer and members receive no compensation for their service. Mr. Roosevelt C. Sands, Jr. has dedicated more than half of a century to the KWHA's mission, and most of his life to serving the residents of the Key West community in a multitude of capacities.
