

NOTICE OF AVAILABLE EMERGENCY HOUSING VOUCHERS

Dear Key West Housing Authority Housing Choice Voucher (Section 8) Applicant:

Effective July 1, 2021 HUD has made available **Emergency Housing Voucher (EHV)** to eligible individuals and families who:

1. Are Homeless
2. At Risk of homelessness
3. Fleeing or attempting to flee domestic violence, dating violence, sexual assault, stalking or human trafficking
4. Recently homeless and for whom providing rental assistance will prevent the family's homelessness or having high risk or housing instability

The availability of these EHV's is managed through a direct referral process. If you believe you meet one of the criteria mentioned above, please visit or call (as appropriate) one of the designated entry points listed below for program application and possible referral. **All applicants must be referred for the Program through the Coordinated Entry System Providers listed below.** Documentation verifying homelessness is required. All application requests must be made in person.
